You are fined \$200.00 and excluded from results of qualifying 1
3	Darren Swinburne	The Clerk of the Course finds that during race 1 you moved over on car #43 at turn 5 causing a collision and forcing car #43 off the track. This is contrary to App 4 Sch Z 12.1 Code of Driving Conduct- careless driving	The Clerk of the Course rules that Penalty Appendix One Schedule P A4Z.7 applies. You are dined \$200.00 and an additional 30 seconds has been added to your race time in race 1
4	Murray Brook	The Clerk of the Course finds that you passed car 7 during race 2 under yellow at entry to turn 1 on lap 6. This is contrary to Appendix Four Schedule Z 11.1(3) Appendix Four Schedule Z 10.11(1) applies. A drive through penalty board and flag was displayed on lap 7	The Clerk of the Course rules that Penalty Appendix One Schedule P- A4Z.2 applies and complied with on lap 8
