1	Nick Buxeda	The Clerk of the Course finds that during Qualifying the Black flag with Orange Disc, and signboard with your car number was displayed for 3 laps, you failed to report to the pits on the next lap This was changed to a Black Flag for the remainder of the qualifying, and you still failed to comply. This is contrary to Appendix Four Schedule Z 11.1 (7).	The Clerk of the Course rules that Penalty Appendix One Schedule P - A4Z.3 applies. You are excluded from the qualifying results and are fined \$300.00. Your licence is endorsed for 6 months until Friday 23 August 2019
2	Kevin Townsend	The Clerk of the Course finds that during qualifying 7 you ran off the Track at Turn 5, and remained stationary in a dangerous position . This caused a full course red flag. This is contrary to App 4 Schedule Z 13.2(1)a	The Clerk of the Course rules that Penalty Appendix One Schedule P - A4Z.4 applies. You are penalised 3 grid places for Race 8
3	Angus Fogg	The Clerk of the Course finds that you jumped the start of race 3. Appendix 4 Schedule Z 8.2 applies. This was judged by Judge of Fact (Starts). Appendix 4 Schedule Z 10.12(1) applies. A "Time Penalty Board" was shown in race 3.	The Clerk of the Course rules that Penalty Appendix One Schedule P - A4Z.8 applies. 10 seconds is added to your race time in race 3.
4	Bruce Anderson	The Clerk of the Course finds that you jumped the start of race 3. Appendix 4 Schedule Z 8.2 applies. This was judged by Judge of Fact (Starts). Appendix 4 Schedule Z 10.12(1) applies. A "Time Penalty Board" was shown in race 3.	The Clerk of the Course rules that Penalty Appendix One Schedule P - A4Z.8 applies. 10 seconds is added to your race time in race 3.
5	Tony Boyden	The Clerk of the Course finds that you jumped the start of race 3. Appendix 4 Schedule Z 8.2 applies. This was judged by Judge of Fact (Starts). Appendix 4 Schedule Z 10.12(1) applies. A "Time Penalty Board" was shown in race 3.	The Clerk of the Course rules that Penalty Appendix One Schedule P - A4Z.8 applies. 10 seconds is added to your race time in race 3.
6	James Penrose	The Clerk of the Course finds that during Race 2 you passed car 32 whilst Yellow lights where illuminated at Flag Point 4 due to a car off the circuit at Turn 5. This is contrary to Appendix Four Schedule Z 11.1 (3)(b)	The Clerk of the Course rules that Penalty Appendix One Schedule P - A4Z.2 applies. That you are fined \$250.00. And an additional 30 seconds is added to your time for race 2.
7	Spike Kohlbecker	The Clerk of the Course finds that during Race 2 you passed car 32 whilst Yellow lights where illuminated at Flag Point 4 due to a car off the circuit at Turn 5. This is contrary to Appendix Four Schedule Z 11.1 (3)(b)	The Clerk of the Course rules that Penalty Appendix One Schedule P - A4Z.2 applies. That you are fined \$250.00. And an additional 30 seconds is added to your time for race 2.
8	Thomas Boniface	The Clerk of the Course finds that during Race 6 you overdrove the circuit at Turn 7 on lap 2, gaining an advantage. This is contrary to Appendix Four Schedule Z 10.2	The Clerk of the Course rules that Penalty Appendix One Schedule P - A4Z.10 applies. That you are fined \$50.00 and 10 seconds is added to your race time.
9	Rob Baker	The Clerk of the Course finds that during Race 27 you continued to drive around the circuit for a further 2 laps after receiving the chequered flag. This is contrary to Appendix Four Schedule Z 15.1	The Clerk of the Course rules that Penalty Appendix One Schedule P - NSC.4 applies. That you are fined \$100.00. Your licence is endorsed for 6 months until Monday 25 August 2019
