Mr Beattie physically pushed Mr Barlow in response to be asked about the incident. Onlookers had to jump in to avoid the situation from escalating.	The Clerk of the Course rules that as per NSC Part VIII 94(7), the matter shall be referred to the Stewards of the Meeting
