1	Phil Blythe	It is alleged that you have: Breached Appendix 4 Schedule Z 12.1 Code of Driving Conduct. Causing an avoidable collision.	The Race Director finds that: You made contact with Car #81 on the entry to the bridge. By your own admission you had not allowed enough racing room and that you were at fault.	The Race Director rules that: Appendix 1 Schedule P A4Z.5 applied. You are fined \$100.
2	Liam Lawson	It is alleged that you have: You caused a red flag during Session Q1 for the 3 Hour Race.	The Race Director finds that: This was due to your car leaving the track at Turn 2 and coming to stop in a dangerous place. It was necessary to stop the session and move your car. Appendix Four Schedule Z 13.2(1) (a) (iii) applies.	The Race Director rules that: Penalty Appendix One Schedule P A4Z.4 applies. Move 3 places back on the grid for the start of Race 2.
3	Chris Nicholas	It is alleged that you have: You caused a red flag during the qualifying session for the 1 hour race.	The Race Director finds that: This was due to your car leaving the track at Turn 9 and coming to stop in a dangerous place. It was necessary to stop the session and move your car. Appendix Four Schedule Z 13.2(1) (a) (iii) applies.	The Race Director rules that: Penalty Appendix One Schedule P A4Z.4 applies. Move 3 places back on the grid for the start of Race 1.
4	Liam Lawson/Scott O'Donnell	It is alleged that you have: Breached 5.2.1 of the New Zealand Endurance Series Racing 2020 Series Articles.	The Race Director finds that: Your car did not run in 3 hour race qualifying session 2. Only one driver participated in session 1.	The Race Director rules that: The rule was breached by both drivers not participating in qualifying. Articles 5.2.1 (a) applies and your car will start behind the last qualified vehicle in its class.
5	Dennis Chapman	It is alleged that you have: Breached Appendix 4 Schedule Z 12.1 Code of Driving Conduct. Causing a collision.	The Race Director finds that: You had an avoidable collision with car #42 (Steff Chambers) This caused car #42 to leave the circuit. Car #42 suffered damage and was disadvantaged in terms of lap times thereafter.	The Race Director rules that: Schedule P A4Z.5 applied. You are fined \$100 and 10 seconds is added to your race time.
6	Sam Collins	It is alleged that you have: Breached Appendix 4 Schedule Z 12.1 Code of Driving Conduct, causing a collision with car #77 at turn 10 of lap 24.	The Race Director finds that: Two cars with a sizeable difference in speed were contesting a very tight part of the circuit. Absolute responsibility for the contact does not fall with any one driver.	The Race Director rules that: This is deemed a racing incident. No penalty is applied
