1	Craig Paddon	The Clerk of the Course finds that you the driver of car 911 did cause a red flag to be displayed during your qualifying session. This is a breach of App 4 Sch Z 13.2(1)(a)(iii) stopping a qualifying or race.	The Clerk of the Course rules that Appendix One Sch P A4Z.4 applies. You will be moved back 3 grid spaces for your first race.
2	Darryn Sutherland	The Clerk of the Course finds that you the driver of car 55 did jump the start at the beginning of your race. This is a breach of App 4 Sch Z 8.2 False Starts.	The Clerk of the Course rules that Appendix One Sch P A4Z.8 applies. A 5 second time penalty is added to your total race time.
3	Paul Clarke	The Clerk of the Course finds that you the driver of car 100 did jump the start at the beginning of your race. This is a breach of App 4 Sch Z 8.2 False Starts.	The Clerk of the Course rules that Appendix One Sch P A4Z.8 applies. A 5 second time penalty is added to your total race time.
4	Pete Fitzgibbon	The Clerk of the Course finds that you the driver of car 40 did jump the start at the beginning of your race. This is a breach of App 4 Sch Z 8.2 False Starts.	The Clerk of the Course rules that Appendix One Sch P A4Z.8 applies. A 5 second time penalty is added to your total race time.
5	Michelle Clarke	The Clerk of the Course finds that you the driver of car 2 did jump the start at the beginning of your race. This is a breach of App 4 Sch Z 8.2 False Starts.	The Clerk of the Course rules that Appendix One Sch P A4Z.8 applies. A 5 second time penalty is added to your total race time.
6	Michael Gallagher	The Clerk of the Course finds that you the driver of car 7 did pass vehicles under safety car full course yellow. This is a breach of App 4 Sch Z 14.2(3) Safety Car.	The Clerk of the Course rules that Appendix One Sch P A4Z.9 applies. A drive through penalty was issued but not completed. A 50 second time penalty was added to your race time.
7	Anthony Davidson	The Clerk of the Course finds that you the driver of car 7 did pass vehicles under safety car full course yellow. This is a breach of App 4 Sch Z 14.2(3) Safety Car.	The Clerk of the Course rules that Appendix One Sch P A4Z.9 applies. A drive through penalty was issued but not completed. A 50 second time penalty was added to your race time. Following a request from the COTC the Stewards find that the penalties applied were incorrectly imposed and the decision is rescinded.
8	David Booth	The Clerk of the Course finds that you made contact with car 87 at turn 4 - hairpin on your race no 1. This caused car 87 to spin and you gained an advantage. This is contrary to Sch Z 12.1 Code of Driving Conduct.	The Clerk of the Course rules that penalty Sch P A4Z.5 applies. You are fined \$100. 12 second penalty will be added to your race time.
9	Gary Duncan	The Clerk of the Course finds that you have been observed passing several cars at turn 9 during race 2- whilst the track is under yellow flag/lights due to safety car deployment. This breaches Sch Z 11.1(3)	The Clerk of the Course rules that penalty Sch P A4Z.2 applies. You are fined \$200. 50 second penalty will be added to your race time.
10	Hugh Gardiner	The Clerk of the Course finds that you the driver of car 15 did jump the start at the beginning of your race. This is a breach of App 4 Sch Z 8.2 False Starts.	The Clerk of the Course rules that Appendix One Sch P A4Z.8 applies. A 5 second time penalty is added to your total race time.
