TRS 2	Cameron Das	The Race Director rules that a report has been received from the Championship Scrutineer in relation to an alleged breach of Schedule TRS. During Technical checks in Parc Ferme following Race 3 at Hampton Downs, your car was found to have mirrors fitted where the mounting stalks had been shortened / modified from standard. Your team have acknowledged that the stalks were modified as a result of your concern with regards to vision at the entry to Turn 5. From a safety perspective, the mirror stalks were adjusted to assist with this. Following Race 3, when your team were made aware of this modification, this was immediately rectified. This modification was considered by the Championship Scrutineer to be Performance Non-Affecting. This is a breach of Schedule TRS Article 15.4 This is Performance Non-Affecting.	The Race Director rules that TRS Article 39.26 applies. A 30 second time penalty will be added to your race time. 3 demerit points. You now have 11 Demerit Points and are to start from the rear of the grid for Race 2. TRS Art 40.5 applies.
