1	Bruce Goodwin	The Clerk of the Course finds that during the qualifying session for Classic Muscle your car stopped on the circuit on the outfield at the entry to turn 8. Race Control deemed the car to be in an unsafe position. This caused the red flag to be displayed. Appendix Four Schedule Z rule 13.2(1)(a)(iii) applies.	The Clerk of the Course rules that Appendix One Schedule P A4Z.4.1 applies. This is a standard penalty. The competitor is moved back three places on the qualifying order for their first race.
2	Dennis Chapman	The Clerk of the Course finds that in race 1 of the Sports and GT's your car had left the grid position and was moving prior to the start signal being given. This was confirmed by Race Control and the Starter. Appendix Four Schedule Z rule 8.2 applies. In conformity with Appendix Four Schedule Z rule 10.12(1) a "Time Penalty Board" was shown in the race.	The Clerk of the Course rules that you jumped the start of race one- Sports & GTs. Appendix One Schedule P A4Z.8 applies and 5 seconds is added to your race time.
3	Craig Paterson	The Clerk of the Course finds that in race 7 Rennsport/Super 6 car #17 (Craig Paterson) hit car #54 in turn 5/6. This caused car #54 to become unsettled and allowed #17 to gain place which was not redressed. This is a breach of Appendix 4.01 Sch Z 12.1- Code of Driving Conduct.	The Clerk of the Course rules that this contact was avoidable and resulted in an advantage. Appendix One Schedule P A4Z.8 applies. Race control applied a drive through penalty. This was complied with.
4	Bruce Street	The Clerk of the Course finds that in race 3 of the BMW E30/NZ6 your car had left the grid position and was moving prior to the start signal being given. This was confirmed by Race Control. Appendix Four Schedule Z rule 8.2 applies. In conformity with Appendix Four Schedule Z rule 10.12(1) a "Time Penalty Board" was shown in the race.
