1	Glenn Johnstone	The Clerk of the Course finds that the competitor did leave the track at turn 4 and cause the qualifying session to be red flagged. This is a breach of App 4 Sch Z Art 12.1 code of driving (stopping a qualifying session)	The Clerk of the Course rules that App 1 Sch P A4Z.4 applies. That the competitor be moved back 3 places in the starting grid of the next race.
2	Brent Jones	The Clerk of the Course finds that the competitor did leave the track at turn 4 and cause the qualifying session to be red flagged. This is a breach of App 4 Sch Z Art 12.1 code of driving (stopping a qualifying session)	The Clerk of the Course rules that App 1 Sch P A4Z.4 applies. That the competitor be moved back 3 places in the starting grid of the next race.
3	Justin Neill	The Clerk of the Course finds that the competitor did breach rule App.4 Sch . Z 11 . 1 (38) by failing to maintain position while under yellow light conditions at Flag Point 1, during qualifying. The yellow flag (lights) were shown at Flag point 1 and you were observed passing Car 9	The Clerk of the Course rules that App.1 Sch. P. A 4 Z 2 applies. \$200 fine is imposed, Excluded from Qualifying results
4	Matthew Carmichael	The Clerk of the Course finds that the competitor did make contact with car no 6 at point 3 of race 3 in turn 4 causing damage to car 6. This is a breach of App 4 Sch Z Art 12.1 (3) causing a collision	The Clerk of the Course after reviewing/hearing all the evidence rules that App.1 Sch. P. A 4 Z. 5 applies. \$100 fine is imposed and a time penalty of 20 seconds is added to race no 3
5	Bernd Kudrass	The Clerk of the Course finds that you were observed "jumping the start" to race no 6. This was confirmed by Judge of Fact Starts. App 4 Sch Z 8.2 applies.	The Clerk of the Course rules that App.1 Sch. P. A 4 Z 8 applies. A time penalty of 20 seconds will be added to your overall race time.
6	Conrad Waldron	The Clerk of the Course finds that the competitor breached the Safety Car Deployment. This is a breach of App 4 Sch Z Art 14.3(6)	The Clerk of the Course rules that App.1 Sch. P. A 4Z.9 applies. A drive through penalty was awarded and completed.
7	Dion Prentice	The Assistant Clerk of the Course finds that the competitor did make contact with car no 16 causing a collision and spin at turn 1 on lap 1 of the OSCA second race. This is a breach App 4 Sch. Z art.12.1 Code of Driving (causing an avoidable accident)	The Assistant Clerk of the Course rules that App.1 Sch. P. A 4 Z 6 applies. \$100 fine. No time penalty will be added as you were classed as a DNF
8	Sam Wallace	The Clerk of the Course finds that the competitor continued to drive outside the confines of the circuit, breaching the circuit regulations. You have been shown the sportsmanship during previous races this weekend to advise of your driving standard. This is a breach of App 4 Sch Z Art 10.2(1) Circuit Regulations	The Clerk of the Course rules that App.1 Sch. P. A 4 Z. 10 applies. A drive through penalty was issued and completed
9	Todd Prujean	The Clerk of the Course finds that the competitor did make contact with car no 1 at point the exit of the sweeper of race 14 causing an avoidable accident. You have been observed making contact with other competitors of this race and your driving standards are being observed. This is a breach of App 4 Sch Z Art 12.1 (3) causing a collision	The Clerk of the Course after reviewing/hearing all the evidence rules that App.1 Sch. P. A 4 Z. 5 applies. The competitor is: Fined \$250.00, and a time penalty of 30 seconds is added to race no 14
10	Rex Edgar	The Clerk of the Course finds that you were observed "jumping the start" to race no 19. This was confirmed by Judge of Fact Starts. App 4 Sch Z 8.2 applies.	The Clerk of the Course rules that App.1 Sch. P. A 4 Z 8 applies. A time penalty of 10 seconds will be added to your overall race time.
