You are penalised 3 grid places for race 1.
3	Tony Roberts	It is alleged that you have: during qualifying you have driven through the pits in excess of the 40kph speed limit. This is in breach of App 4 Sch Z 10.1(2)	The Clerk of the Course finds that: this was observed by judge fact pits. And recorded on the speed rader at the pit exit at 53kph	The Clerk of the Course rules that: App 1 Sch P A4Z.11 applies. You are excluded from qualifying.
4	Malcolm Fleming	It is alleged that you have: Jumped the start of race 1. App 4 Sch Z 8.2 applies.	The Clerk of the Course finds that: Moved outside of grid box prior to the start lights being extinguished. This was judged by judge of fact starts- App 4 Sch Z 10.12(1) applies. A "Time Penalty Board" and flag with your car # was shown in race 1.	The Clerk of the Course rules that: App One Sch P A4Z.8 applies. 5 seconds is added to your race time in race 1.
5	Robert Hulme	It is alleged that you have: Jumped the start of race 4. App 4 Sch Z 8.2 applies.	The Clerk of the Course finds that: You were out of formation under the rolling start prior to the green light being illuminated.
