John Blaikie		The Stewards find that the competitor failed to acknowledge an Official Signal, being a Black Flag with your car number (9) with the words 'Drive Through Penalty' displayed on the Signaling Board at the Start/Finish Line for three (3) Laps. This was then changed to a Black Flag with your car number (9) displayed on the Signalling Board for the remainder of the race.  You failed to acknowledge the Official Signal for the duration of the race and only when you came into the Pits after the Chequed Flag did you enquire as to why it was displayed with your car number for the duration of the race. You stated that you saw the Flag and Signal, but also stated that you did not feel that you had done anything wrong and the car was safe due to you being 20 secs ahead of the field and you knew that you had not interferred with any	The Stewards rule that Schedule P Article A4Z.3 applies.
