Upon inspection, no ballast plates were found. A hearing was held with Mark Pilcher (M2 Competition) who accepted the technical infringement report. It was determined that this breach would be considered Non-Performance affecting due to the fact your Car did meet the minimum weight requirements. Evidence was presented by the Championship Scrutineers and TGRNZ in respect of the breach which showed that the impact on the vehicle camber was negligible and hence it was determined that this breach would be considered Non-Performance affecting.
