1	Leo Bult	The Clerk of the Course finds that: Watching your race (race 5) from race control it appeared that you made contact with car 88 at turn 9 and that you caused car 88 to spin and not able to continue. After putting the incident under investigation and viewing additional in car video evidence it has been concluded that you did cause contact with car 88 at turn 9.	This is a breach of A4 schedule Z 12.1 causing a collision	The Clerk of the Course rules that: A4Z.5 applies and that you be fined \$100.00 and that 30 seconds be added to your race time
2	Mauro Iglesias	The Clerk of the Course finds that: An inquiry was received that you crossed the pit entry control line during race 11 and on investigation this is clearly viewed from the video evidence from race control. A notice to appear at a hearing with the Cote was issued and at the hearing additional video evidence was produced by you (the driver of car 81) and that you were escorted across the control line by car 46 who appears not to have seen you. The video shows that you immediately lifted from the throttle and rejoined the circuit safely.	This is a breach of Pitlane regulations and the rule as outlined in the written drivers briefing	The Clerk of the Course rules that: You were not at fault and that your actions avoided a collision with car 46. No penalty will be issued.
3	Josh Melrose	The Clerk of the Course finds that: As a result of judge of fact decision (Sam Thomson starts) that you started from the wrong grid position, a time penalty board and your car number was displayed. Further into the race it was discovered that you did in fact start from the correct position and that the penalty was issued in error as the correct grid position sheet was not given to timing before the race.	This is a breach of App 4 Sch. Z 8.2 False Starts	The Clerk of the Course rules that: No infingement occurred. Therefore no penalty will be issued.
TR86 001	John Penny	The Race Director finds that: You did not attend the category specific drivers briefing schedules as per the Supplementary Regulations. A hearing was held with your team representative who confirmed you were not at the circuit. The team representative stated that apologies had been put in on your behalf but TGRNZ Category Management have not received any apologies, nor have I.	Breach of Schedule CH Art 25.4	The Race Director rules that: Penalty CH 40.6 applies. \$300 fine.

You have alleged to have breached the 2021 / 22 MSNZ approved V8 UTE's Series Technical Regulations Racing Weight- 8.0	The Race Director rules that: You have breached the 2021/22 MSNZ approved V8 UTE's Series Technical Regulations - Racing Weight- 8.0. Penalty CH 40.9 is imposed. You are fined \$600. You are excluded from the VS UTE's Qualifying session. Your competition licence is endorsed for 1 month to the 20th May 2022.
