A hearing was held with your team representative, a representative from the inquirer (Car 4), the Championship Scrutineer and the Toyota 86 Championship Technical Manager. The inquirer submitted that by running the tyre in the opposite direction from the arrow on the tyre (which the Championship Scrutineer and Technical Manager confirm is to indicate the direction the tyre should be run in), this is a breach of Schedule TR 86 - not using a control part as supplied. Your team representative submitted that this was done for safety reasons and disputed the application of the rule. The Championship Scrutineer and Technical Manager submitted there was no specific advisory to run the tyres in the direction which the arrow indicated, however used an example of another control part which had an arrow on it, which would be considered a breach if it was not installed in that direction. Post the hearing they confirmed to me that this breach would be considered non-performance affecting.  I agree with the inquirer in respect of the breach and agree with the Championship Scrutineer in respect of being non-performance affecting.
