**ALLEGED RULE BREACH:** *(Quote the rules breached and why)*

It is alleged that you have: breached Appendix Four Schedule Z Article 13.2(2) of the current MotorSport New Zealand Manual by re-entering the circuit in a manner that has impeded another competitor (#5 Shane Gray). The Clerk of the Course issued a penalty of 10 seconds to be added to the race time of competitor #28 (Troy Wheeler). Competitor #28 (Troy Wheeler) has protested the decision of the Clerk of the Course.

**FINDING:** *(Quote what your finding is and why)*

The Stewards find that: having summoned competitor #28 (Troy Wheeler) and with the Clerk of the Course and the Driving Standards Officer also present, and having reviewed the evidence and video footage provided from competitor #28 (Troy Wheeler) and video footage and data tracing from competitor #5 (Shane Gray) that although competitor #28 (Troy Wheeler) re-entered the circuit immediately in front of competitor #5 (Shane Gray) there is sufficient evidence that competitor #28 (Troy Wheeler) has shown sufficient caution in re-entering the circuit, and there is insufficient evidence that competitor #28 (Troy Wheeler) has interfered with, or impeded the progress of, competitor #5 (Shane Gray). It was clear to the Stewards that from the video footage provided competitor #5 (Shane Gray) was not forced to take evasive action or brake significantly in a manner consistent with having been impeded.

The Stewards rule that: the protest is upheld and the protest fee is to be returned to competitor #28 (Troy Wheeler).
