ALLEGED RULE BREACH: (Quote the rules breached and why)  It is alleged that you have breached Appendix Four, Schedule Z, Article 8.3 by crossing your starting grid line before the start signal was given for your handicap group for Race 6.  Decision BT03 from the Clerk of the Course has penalised you by adding 20 seconds to your race time for Race 6.  The Clerk of the Couse has since requested that this decision be rescinded as it has since been established that you were provided with an incorrect grid sticker, and that you did start the race in the position you were notified.						
FINDING: (Quote what your finding is and why)  The Stewards find that having considered the information provided by the Clerk of the Course that an error in providing you with an incorrect grid sticker meant that you inadvertently started from an incorrect grid position, but you did start from the grid position provided to you, and would not have known otherwise that an error had been made.						
DECISION TO BE APPLIED: (Quote applicable penalty)  The Stewards rule that under their authority under Article 77(10) of the National Sporting Code of the MotorSport New Zealand Manual 36 that Decision BT03 from the Clerk of the Course be rescinded and the time penalty of 20 seconds added to the race time of Competitor #67 (Steve Prentice) be removed.
