2021 Golden Homes North Island Endurance Series Amendment

This amendment is issued under the provisions of the MotorSport NZ National Sporting Code Article 18(2) in confirmation that the following amendments, notices or points of clarification have been authorised to the text of the Supplementary Regulations of the above-named event. It is recommended that in addition to retaining a copy of this bulletin all parties modify the text of the regulations according to the following:

Series Amendment

- 1. Amend Article 3 as stated in the schedule below.
- 2. Amend Article 5 as stated in the schedule below.
- 3. Amend Article 15 as stated in the schedule below.
- 4. Amend Article 32 as stated in the schedule below.

1. 3.5 TWO HOUR RACE:

3.5.1 Only Class 1, 2, 3 or 4 vehicles as determined in Article 3.3 are eligible to enter the Two Hour Race providing they do not go faster than the following "break out" lap times:

If a vehicle exceeds any of the breakout lap times as above during qualifying or during the race, penalties will be issued in accordance with Article 32.

Reason: Clarification on when penalties will be applied upon breaking out.

2. 5 SERIES STRUCTURE:

5.1 The Series shall comprise of the following Rounds:

3. 15 POINTS:

15.1 Points will be recorded and published by the Series Coordinator and will be allocated to Drivers based on their overall finishing positions in each Race, at each Round of the Series. At the conclusion of the season, point scores from a Team's worst points scoring round from either Round 1, 2 or 3, will be excluded from the final points total.

Reason: To include Round 4 as one of the eligible rounds to be dropped.

4. 32 PENALTY SCHEDULE:

32.11	First breakout lap during the race	Black / White flag with your car number
32.12	Second breakout lap during the race	10 Second Time Penalty
32.13	Third breakout lap and thereafter during the race	Drive through penalty

32.15	Any breakout laps during qualifying	Moved to the back of the grid for the 2 Hour race. If there is more than one competitor who goes faster than the "break out" lap times, they will be placed at the rear of the grid according to their relative times, with the fastest breakout qualifying time last.

Reason: To clarify the penalty for breaking out during the two hour race.
