# NZ Formula Ford Championship Championship Articles Amendment

This amendment is issued under the provisions of the MotorSport NZ National Sporting Code Article 18(2) in confirmation that the following amendments, notices or points of clarification have been authorised to the text of the applicable championship regulations. It is recommended that in addition to retaining a copy of this bulletin all parties modify the text of the regulations according to the following:

#### 1. 2 ELIGIBILITY:

- **2.2 Eligibility Criteria:** Competitors must compete in either of the Qualifying Series prior to the start of the Championship to be eligible for entry into the NZ Formula Ford Championship.
  - (a) The top twenty(20) competitors in each Qualifying Series as at 14 December 2021 at the close of entry to the first Championship Round will automatically qualify for the Super Rounds Championship.
    - (i) Eligible competitors who do not wish to contest the Championship must notify their Qualifying Series' Coordinator by 5pm on 16 December 2021 11 February 2022.

#### 2. 2 ELIGIBILITY:

2.3.1 If a competitor changes a vehicle during the Qualifying Series or the Championship rounds, they must inform their respective Championship Coordinator(s).
