

2021-22 Race Championship Series

Pirelli Porsche NZ Race Championship Championship Technical Amendment

This amendment is issued under the provisions of the MotorSport NZ National Sporting Code Article 18(2) in confirmation that the following amendments, notices or points of clarification have been authorised to the text of the Technical Schedule of the above named class. It is recommended that in addition to retaining a copy of this bulletin all parties modify the text of the regulations according to the following:

Championship Technical Amendment

1. Amend Article 3 as stated in the schedule below.
2. Amend Article 12 as stated in the schedule below.
3. Amend Article 13 as stated in the schedule below.
4. Amend Article 14 as stated in the schedule below.

1. 3.0 ELIGIBLE VEHICLES

- 3.1 **Eligible vehicles:** Authorised to take part in competition under these regulations shall be:

(...)

- (6) **Class D:** Being Porsche model 964 (Cup, RS and replicas thereof), model 993 (Cup, RS and replicas thereof), Cayman (excluding GT4 Clubsport), Boxster (2.7 after 2002, and all 3.2 and 3.4 litre engine) and 928 cars, and forced induction models of 944, 968, Boxster or Cayman cars, in compliance with Schedule PC.

Reason: To align eligibility with those listed in the Championship Articles.

2. 12.0 CLASS D

- 12.1 **Eligible vehicles:** Being Porsche model 964 (Cup, RS and replicas thereof), model 993 (Cup, RS and replicas thereof), Cayman (excluding GT4 Clubsport), Boxster (2.7 after 2002, and all 3.2 and 3.4 litre engine) and 928 cars, and forced induction models of 944, 968, Boxster or Cayman cars, in compliance with Schedule PC.

Reason: To align eligibility with those listed in the Championship Articles.

3. 13.0 CLASS E

13.13 Tyres:
(...)

- (2) **Authorised Tyres:** With the exception of 13.13(1), only the following specified control tyres are authorised for use under this schedule.
- ~~Pirelli Trofeo R~~, Nankang AR-1 (Dry) and ~~Pirelli~~ WH treaded wet tyres.

Reason: *Dry control tyre changed due to supply issues.*

4. 14.0 CLASS E



14.14 Tyres:

- (2) **Authorised Tyres:** With the exception of 14.14(1), only the following specified control tyres are authorised for use under this schedule.
- ~~Pirelli Trofeo R~~ Nankang AR-1 front 225/45-17 only.
 - ~~Pirelli Trofeo R~~ Nankang AR-1 rear 255/40-17 only.
 - Pirelli Wet tyres must be used when a meeting is declared wet.

Reason: *Dry control tyre changed due to supply issues.*
