**Session:** Qualifying 1

**Fact:** An Official Protest was lodged by mtec Motorsport on behalf of the above listed drivers.

**Background:** The Stewards, after hearing from the Team Representative and Drivers of Car 3, Car 5, and Car 11, have determined the following.

The nature of the protest was that the team considered that they were unable to complete a flying Qualifying lap because of the red flag conditions and their position in pit lane. For that reason, they consider that they have not been able to complete a flying lap, Qualifying 1 should be abandoned.

They have also relied on Article 34.3.1(a) of the 2026 Sporting Regulations as their interpretation for having to do a fastest lap for Race 1.

**Decision:** The Stewards have considered the argument put to them by the Team Representative and Drivers and have determined that there is no provision in the 2026 Sporting Regulations that states that the fastest lap must be achieved by a flying lap.


Article 34.1 determines that the fastest time achieved by each driver will be officially published and that will apply.

The published provisional times for Qualifying 1 show the fastest lap times achieved by Car 3, Car 5, and Car 11. These lap times are the fastest times that apply for those cars.

There is no provision in the 2026 Sporting Regulations for Qualifying to be abandoned on the basis of the argument that was put to the Stewards.

The Stewards determine that the protest has failed and the protest fee will be retained.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.


**Reason:** No driver was found to be solely responsible for the issue of the red flag during Qualifying 2.

**Decision:** The Stewards, having examined video evidence and after hearing from the driver and team representative(s) of Car 27 and Car 19 as a post-race investigation, determine that a breach of Article 15.1(d) and 15.1(e) of the 2026 FIA Castrol Toyota Formula Regional Oceania Trophy Sporting Regulations occurred, where Car 27 caused disadvantage to Car 19. **Reason:** Car 27 caused a collision causing disadvantage to Car 19, where Car 19 was forced off the track.


