A 10 Second Time Penalty is applied to Car 5 for Race 27, Steve Ross is fined the sum of \$100. Competition Licence 931142X is endorsed for the period of 3 months ending on 1st February 2021. You must keep a copy of this decisions with your licence for the period of the endorsement.
