You still did not acknowledge the flag.	The Clerk of the Course rules that: App 1, Schedule P A4Z.3 applies. You are fined \$400.00. You are excluded from Round 2 of the BMW Series. Your licence is endorsed until 26th July 2021.
4	Hayden Bakkerus	It is alleged that you have: exceeded valv lift limits. This is in breach of Formula First Schedule V, Art 9.10.2	The Clerk of the Course finds that: Engine Valve Lift checks were taken by the class technical officer after the prescribed cool down period of 20 minutes. And one valv lifter was found to be 9.33mm. This meant that Formula First Schedule V, Art 9.10.3 was applied, which has then given an average of 9.33 total. You acknowledge that this has occurred as an error as the car has only just been purchased and no intent was made by yourselves to enhance the motor.	The Clerk of the Course rules that: App 1 Schedule P A2A.2 applies. You are fined \$100. You are excluded from Race 1. Your licence is endorsed until 24th November 2020.
