You are moved three (3) places back in the starting grid for Race 7
2	Glenn Gordon	It is alleged that you have: Your vehicle was moving prior to your handicap start flag for Race 4. This is in breach of App 4 Schedule Z 8.2	The Clerk of the Course finds that: This was observed by judge fact starts. Which Appendix 4 Schedule Z 10.12(1) applies.	The Clerk of the Course rules that: App 1 Schedule P A4Z.8 Applies. The signaling board with your car number and the words Time Penalty was displayed on Lap 2. 5 seconds is added to your race time in Race 4
3	lan Humphrey	It is alleged that you have: You have Driven through the pit exit whilst the red light for pit exit control light was illuminated for the start of race 6. This is in breach of App 4 Sch Z 8.6.	The Clerk of the Course finds that: This was observed by race control. And following discussion with yourself you have also confirmed this to be the case.	The Clerk of the Course rules that: The Black flag was displayed on Lap 2 and you complied on Lap 4. You are excluded from Race 6. You are fined \$100.00.

This is in breach of App 4 Schedule Z 8.2	The Clerk of the Course finds that: This was observed by judge fact starts.  Which Appendix 4 Schedule Z 10.12(1) applies.	The Clerk of the Course rules that: App 1 Schedule P A4Z.8 Applies. The signaling board with your car number and the words Time Penalty was displayed on Lap 2. 5 seconds is added to your race time in Race 8
6	Darryl Hunter	It is alleged that you have: Collided with another competitor forcing vehicles of the circuit Appendix Four Schedule Z 12.1.	The Clerk of the Course finds that: Upon listening to all parties and hearing your explanation of the event that occurred in Turn 1 of Lap 1, and having now had the opportunity to review the supplied video footage.  You have had a lock up on the right front wheel in the middle of Turn 1 which has resulted in you not having control and impacted into car #57, forcing car #57 off the circuit.	The Clerk of the Course rules that: Penalty Appendix One Schedule P – A4Z.7 applies. You are fined \$100.00. You have an additional 20 seconds added to your race time for Race 16.
7	Jamie Potts	It is alleged that you have: Your vehicle left prior to your handicap start flag for Race 17. This is in breach of App 4 Schedule Z 8.2.	The Clerk of the Course finds that: This was observed by judge fact starts. Which Appendix 4 Schedule Z 10.12(1) applies.	The Clerk of the Course rules that: App 1 Schedule P A4Z.8 Applies. The signaling board with your car number and the words Time Penalty was displayed on Lap 2. 10 seconds is added to your race time in Race 4
