This is in breach of Schedule Z Article 13.2	The Clerk of the Course rules that: Schedule P A4.Z.4 Applies You are to be moved back 3 grid spaces at the start of the next race.
2	Tim Edgell	It is alleged that you have: Caused a red flag to be displayed during your qualifying session	The Clerk of Course finds that: Red flag/lights were displayed during the Formula Open Qualifying session due to your car exiting the track at Turn 2 And stopping in a dangerous position. This is in breach of Schedule Z Article 13.2.	The Clerk of the Course rules that: Schedule P A4.Z.4 Applies You are to be moved back 3 grid spaces at the start of the next race.
3	Jason Galbraith	It is alleged that you have: Jumped the start in your first race.	The Clerk of Course finds that: You were observed by Judge of Fact Starts to have made a false start. You had left your grid position before the start lights were extinguished. This is in breach of Schedule Z Article 8.2	The Clerk of the Course rules that: Schedule P A4.Z.8 Applies Addition of 10 seconds added to your race time.
4	Piers Mingham	It is alleged that you have: Jumped the start in your first race.	The Clerk of Course finds that: You were observed by Judge of Fact Starts to have made a false start You had left your grid position before the start lights were extinguished This is in breach of Schedule Z Article 8.2	The Clerk of the Course rules that: Schedule P A4.Z.8 Applies Addition of 10 seconds added to your race time.
5	Kevin Ingram	It is alleged that you have: Caused a red flag to be displayed during your qualifying session	The Clerk of Course finds that: Red flag/lights were displayed during the Formula 5000 Qualifying session due to your car making contact with Car 14 at Turn 2, causing car 14 to stop in a dangerous position. This is in breach of Schedule Z Article 13.2.	The Clerk of the Course rules that: Schedule P A4.Z.4 Applies You are to be moved back 3 grid spaces at the start of the next race.
6	Peter Stewart	It is alleged that you have: Caused two driving incidents during your race, damaging one vehicle and causing the second to crash into the tyre wall.	The Clerk of Course finds that: You made contact with Car 177 at Turn 6 on lap 1, gaining an unfair advantage and you also made contact with Car 336 After receiving the chequered flag at Turn 1, causing this car to crash. This is in breach of Schedule Z Article 12.1 Code of Driving Conduct - careless driving causing an accident.	The Clerk of the Course rules that: Schedule P A4.Z.6 Applies You are fined \$150. You are excluded from Race 11 Results. Your competition licence is endorsed for one (1) month from 06 February 2021.
7	Paul Ringland	It is alleged that you have: Jumped the start in your lollipop handicap race.	The Clerk of Course finds that: You were observed starting your race from the incorrect flag point (FP7) This was deemed a false start. This is in breach of Schedule Z Article 8.2	The Clerk of the Course rules that: Schedule P A4.Z.8 Applies Addition of 20 seconds will be added to your race time.
8	Scott O'Donnell	It is alleged that you have: Jumped the start in your rolling start race.	The Clerk of Course finds that: You were observed not maintaining your grid position during the rolling start This was deemed a false start This is in breach of Schedule Z Article 8.3 (2).	The Clerk of the Course rules that: Schedule P A4.Z.9 Applies Addition of 10 seconds will be added to your race time
