Race Control deemed the car to be in an unsafe position. This caused the red flag to be displayed. Appendix Four - Schedule Z - Rule 13.2 (1)(a)(iii) applies.	The Clerk of the Course rules that: Appendix One- Schedule P - A4Z4.1 applies. This is a standard penalty. The competitor is moved back three places in the qualifying order for their first race.
2	Barry Morgan		The Clerk of the Course finds that: During the qualifying session for Mainland Muscle Cars your car stopped on the circuit on the outfield at the exit of turn 4. Race Control deemed the car to be in an unsafe position. This caused the red flag to be diselayed. Appendix Four - Schedule Z - Rule 13.2 (1)(a)(iii) applies.	The Clerk of the Course rules that: Appendix One- Schedule P - A4Z4.1 applies. This is a standard penalty.  The competitor is moved back three places in the qualifying order for their first race.

The Clerk of the Course finds that: During the race your car exceeded maximum noise by a sizeable margin on two successive laps. Race control displayed a black flag with your car number for 3 laps. Your car did not come to the pit lane as required by the rule. You ignored/failed to respond to an official signal.	The Clerk of the Course rules that: Appendix 1 Schedule P A4 Z.2 applies. You are fined \$100. You are excluded from the results of Race 8 (Race #1) for Mainland Muscle Cars

Schedule four - Schedule Z - rule 8.2 applies.  In conformity with Appendix four- Schedule Z rule 10.12(1) a 'time penalty board' was shown in the race.	The Clerk of the Course rules that: You jumped the start of Race 11 - Sports and GT's. Appendix one - Schedule P A4Z.8 applies and 5 seconds is added to your race time.
