The Stewards, having received a report from the Technical Delegate and the Championship Tyre Supplier, have considered the following matter, determine the following:

Driver and Car No: Yuanpu Cui Car 5 / Sebastian Manson Car 22

Competitor: mtec Motorsport / M2 Competition

Fact: A tyre supplied to the above listed Competitors was damaged prior to it being supplied to them.

Decision: The above listed competitors are permitted to replace the damaged tyres with tyres as approved by the Technical Delegate under the authority of the Stewards as designated by Article 11.7 of the International Sporting Code.

Reason: Having considered the matter extensively, the Stewards determined that the competitors were provided tyres from the Championship Tyre Supplier that are “out of round” due to damage caused during shipping. The Stewards find that due to this not being the fault of a competitor, rather damage caused during shipping, and that this is a matter that is not foreseen in the Sporting or Technical Regulations, that it is appropriate to use the powers granted under Article 11.7 of the ISC to permit the tyres to be replaced.
