The Signalling Board with your car number and the words "Time Penalty" and a Black/White flag was displayed both at the start line and on 'MegaVis' for Lap 2. 5 seconds is added to your race time for Race 3
Michael Jury	The Clerk of the Course finds that: You passed the Safety Car on the exit of Turn 7, whilst the safety car was still deployed with its yellow lights on, and all the flag points displaying SC and yellow lights. You have admitted to doing this, and have advised it was an error of judgement on your part.
