This was admitted by you and you claimed that they were being a bully and should have had discretion as the 10 year old knew what he doing. When I also asked you about a further report that had come in to myself in relation to the you being abusive to another official, you advised that "some fat guy had spoken to you and advised that we don't tolerate abuse of the marshalls, and you had responded with ""who are you to tell me, do you just flip burger during the day?""	This is a breach of NSC 94 (7)	<b>The Clerk of the Course rules that:</b> Having had this conversation with you, I believe there has been an abuse of an official and as such I am passing this matter on to the stewards for a further hearing as to penalty.
