The driver did not approach the organisers but allowed the proposed driver to seed permission, which he did, but was denied.	<b>The Stewards Rule that:</b> 1. Z.4 and NSC 37 were breached by the competitor. 2. NSC 94(c) did not apply
			3. Notwithstanding, the replacement driver drove the car in the race. We accept that the Competitor assumed permission had been granted and did not enquire further given his experience of himself been allowed to do the same thing the year before at the same meeting.	3.
