2023-24 NZ Formula Ford Championship Series Article Amendment

This amendment is issued under the provisions of the MotorSport NZ National Sporting Code Article 18(2) in confirmation that the following amendments, notices or points of clarification have been authorised to the text of the Series Articles of the above-named Series. It is recommended that in addition to retaining a copy of this bulletin, all parties modify the text of the regulations according to the following:

Championship Series Article Amendment:

1. Amend Article 6.3 as stated in the schedule below.
2. Amend Article 6.4 as stated in the schedule below.
3. Amend Article 6.5 as stated in the schedule below.
4. Amend Article 6.7 as stated in the schedule below.
5. Amend Article 7.3 as stated in the schedule below.
6. Amend Article 7.4.3 as stated in the schedule below.

1. Item One:

6.3 Practice: there shall be three(3) official Practice sessions of minimum of fifteen (15) minutes durations held on the Friday of each Round.

6.3.1 Practice starts during any Practice session are permitted only at the pit exit speed de-restriction line provided that any Car that is following is not delayed or hindered at any time.

Reason:

Clarification on when and where a practice start may take place.

2. Item Two:

6.4 Qualifying (...)

6.4.1 Vehicles will assemble at the Assembly Area for Qualifying in approximate lap time order from the previous official Practice session.

6.4.2 Practice starts when leaving pit exit during Qualifying are not permitted.

Reason:

*Removal of "approximate" to ensure all vehicles assemble in lap time order.
Clarification on when and where a practice start may take place.*

6.5 Race lengths: Races are scheduled to run as follows:

1	10 laps	10 laps	10 laps	12 laps

4	10 laps 20 minutes	10 laps 20 minutes	12 laps 20 minutes	N/A

Reason: Update of race distance measurement at Round 4 from laps to time certain.
