It was alleged that car #12, Dalan, had moved twice under brakes in Turn 5 (The Carousel) causing a collision.

A Race Inquiry was received from Tomas Climo the driver of car #2.

It was alleged that car #28 had moved across on him at the entry to Turn 10 in lap 5 of race 3 denying him racing room, causing him to take avoiding action and losing a place. Tomas considered this unsafe.

A hearing was held during which verbal accounts of the incident were related by both drivers. In-car video from car# 2 was also reviewed. It was established that:

- Car #2 had established sufficient overlap to be given racing room
- Car #28 turned across him leaving less than one cars width to the edge of the track
- Car#2 took avoiding action and in doing so went outside track limits
- Car #2 lost a place in the racing order – this is deemed a negative effect


