Kane Lawson	The Clerk of the Course finds that: Car 89 Made contact with Car 908 Mana Malmezac, Francois Beziac at turn 8. This has resulted in Car 908 withdrawing from the Race. The onus is on the overtaking vehicle and this has caused a negative effect of Car 908.	This is a breach of rule: Appendix 4 Schedule Zart 15 .3.	The Clerk of the Course rules: Car 89 Is fined a sum of \$100 and has 12 seconds added to race time.
