You are moved three(3) places back in the starting grid of Race 1.
Benjamin Van der Werff	The Clerk of the Course finds that: During qualifying, you lost control of your car, and came to a stop in a dangerous position on the outside of T1 in the gravel trap. This caused the session to be red flagged.	This is a breach of rule: Schedule Z article 9.2 (C) applies. Causing a red flag in a qualifying session.	The Clerk of the Course rules: Schedule P A4Z.4 applies. You are moved three(3) places back in the starting grid of your Race 1.
Marvyn Towers	The Clerk of the Course finds that: You jumped the start of Race 4- leaving the grid before your handicap time.	This is a breach of rule: Schedule Z article 8.3(1)	The Clerk of the Course rules: Schedule P A4Z.8 applies. A time penalty board and flag was displayed 5 seconds added to your race time for Race 4
Sean Kirkpatrick	The Clerk of the Course finds that: During the Safety Car Period in Race 4, you overtook cars 25 and 92 after the safety car boards flags and lights had been deployed. There was sufficient time for you to have seen more than one flag point. The passes were made between Turns 8, 9 and 10.	This is a breach of rule: Schedule Z article 10.2 (3)	The Clerk of the Course rules: Schedule P A4Z.9 applies. 10 seconds is added to your time for race 4 .
Sean Kirkpatrick	The Clerk of the Course finds that: During race 2 for your class, you broke out of class eligibility by more than one second. This is a breach of series articles.	This is a breach of rule: 2023 - 2024 GTRNZ Series Articles - last amended 030224 - 8.1.IC - Quicker .. than their class eligibility from 00:01.001 .	The Clerk of the Course rules: Series Articles 8.1.IC applies. You are disqualified from the results of Race 2 .
Dave Icceton	The Clerk of the Course finds that: You jumped the Start of Race 3 - rolling before the start signal was given. This was judged by Judge of Fact Starts.	This is a breach of rule: Schedule Z Article 8.3(1)	The Clerk of the Course rules: Schedule P A4Z.8 applies. A time penalty board and flag was displayed and 5 seconds added to your race time for Race 3
Sean Kirkpatrick	The Clerk of the Course finds that: During the Safety Car Period in Race 3, you overtook cars 43 and 15 after the safety car boards flags and lights had been deployed. There was sufficient time for you to have seen more than one flag point. The passes were made at the entry and exit of T10. You did redress the pass on car 15, but not car 43 .	This is a breach of rule: Schedule Z article 10.2 (3)	The Clerk of the Course rules: Schedule P A4Z.9 applies . 20 seconds is added to your time for your race 3 .
Shane Parsons	The Clerk of the Course finds that: During your race 3, on the straight between T9 and T10, you continued to weave after the safety car .. had extinguished its lights prior to the restart.	This is a breach of rule: Schedule Z article 10.2 (3) and .. written .. drivers briefing .	The Clerk of the Course rules: Schedule P A4Z.9 applies. 5 seconds is added to your time for your race 3.
